I, THE UNDERSIGNED, HEREBY ACKNOWLEDGE THAT I AM FULLY AWARE OF THE INHERENT RISKS AND DANGERS OF ALL EQUINE AND HORSE-RELATED ACTIVITIES, INCLUDING BUT NOT LIMITED TO HARM, BODILY INJURY OR DEATH WHICH MAY OCCUR TO A PARTICIPANT, RIDER OR SPECTATOR, OR TO ANY HORSE.

Accordingly, I hereby assume and accept the full risks and dangers of, and responsibility for, my participation in such activities, waive any claim for and release and agree to hold harmless and indemnify SUN PONY RANCH, INC. of 18490 County Road 1, Berthoud, CO, 80513, its shareholders, directors, officers, and their heirs, executors, administrators, and its employees, agents, successors and assigns, from and against any and all liability and/or responsibility, and any and all claims, demands and/or causes of action, for any accident, damage, injury, illness and/or death to any horse and/or any other property, and/or to the undersigned and/or to any family member, friend or spectator accompanying the undersigned to or on the above property and/or any horse show or equine or horse-related activity or facility.

I agree to accept and abide by all safety rules of the above property and activities, including, without limitation: (a) no smoking; (b) all riders and students must wear ASTM/SEI approved helmets at all times when mounted; (c) all riders and students must follow the safety directives of the instructor; and, (d) such other rules and directions as shall be adopted for the above property and /or for the activities.

There are potential dangers of horseback riding. These dangers include, but are not limited to:
Injury as a result of the unpredictable nature of a horse's temperament.
Injury as a result of the unforeseen intervention of a third party, other than myself and the horse that I ride, be it another horse, another animal, another human or an insect.
Injury as a result of an unforeseen injury or ailment of the horse.
Injury as a result of the failure of a piece or equipment that occurred after a complete and reasonable inspection by the staff and/or owners of Sun Pony Ranch, Inc.

WARNING

Under Colorado Law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to section 13-21-119, Colorado Revised Statutes.
